Treasurer's Report

- Hot Dog Lunch Sold 171 hot dog lunches (18 of those donated) Total Revenue \$729.75 Profit of \$374.00
- Pizza Hut Lunch Sold 197 pizza lunches (10 of those donated) Total Revenue \$1638.00 Profit of \$631.73
- Bottle Depot Acct#2416- Once we hit \$100 in donations a Cheque will be sent to the school for us to deposit
- Balance of accounts to date: \$33,222.33. current balance is less than starting balance of the year due to outstanding invoices not paid to the previous Executive for monies owed for hot lunches and school events dating back early 2023. Transactions performed prior to new council executive having control of society accounts. Receipts and details have been submitted by previous chair regarding transactions.
