2. Crooked Creek Donut Fundraiser Information:
a. We set November $6^{\text {th }}$ as the delivery day for those who chose to order donuts
b. Below is the information provided to Nicole

Good Day Nicole,
I apologize for the delayed response!
Yes we do fundraisers, and will be starting again this fall/winter. Basically, 1)together we set a day that works for both of us, 2)you take the orders and send it to us a week in advance, 3)we make it up for you, fresh on day of order 4)you send someone to pick it up, and hand them out same day! We give you a discounted price and you sell for $\$ 5 / \mathrm{dz}$ more. We do like to do Mondays, Tuesdays or Thursdays, but we do work with other days if that is what is best for you.
The first price is what you pay us and the second price is what you charge.
Glazed donuts \$16/dz - \$21/dz
Cinnamon sugar $\$ 16 / \mathrm{dz}$ - $\$ 21 / \mathrm{dz}$
Half glazed half cinnamon sugar $\$ 16 / d z-\$ 21 / d z$
I will attach a sheet we use for orders. We max out between about 70-90dz per day. We have often done more than one pick up if needed.
